Resolution Adopting the Capital Improvement Fee (CIP) Schedule for the Western Amador

Recycling Facility (WARF) and the Pine Grove Transfer Station

At the June 23, 2020 Board of Supervisors meeting, the Board Authorized a new updated WARF contract with ACES Waste Services, Inc. Section 14.0 (C.) authorizes new Capital Facilities Fees to help offset the cost of capital improvements mandated by the State of California as well as other prioritized capital projects which are needed to provide security, fire suppression capabilities and SWPPP/Groundwater contamination control. All of these are site related issues which are incumbent upon the County to maintain as the owner of the Buena Vista Landfill site.

Although the landfill is closed, the County is still responsible for post closure management and maintenance of all continuing issues associated with the previous operation of a landfill facility. This includes maintenance and monitoring of the closed waste management units 1,2 and 3 and the associated surface impoundment. This must continue until the site no longer constitutes a threat to the environment. Post closure periods begin at 30 years and are re-evaluated periodically from an operational and financial responsibility perspective. In addition to maintaining an monitoring the site, the County is also responsible for financially assuring the completion of any corrective actions that may occur during the post closure period.

Currently the County is undertaking the design and ultimately the construction of a <u>Final Cover Reconstruction for Waste Management Unit I</u> and the <u>Expansion and Liner Replacement of the Class II Surface Impoundment</u>. These projects are mandated by the Regional Water Quality Control Board. They are currently in the design phase and will be going to construction in the spring/summer of 2021. To qualify for financing the County must show an ability to repay the debt service for these projects. A portion of the new fees will be dedicated for this purpose.

There are a number of other capital projects, which will be implemented as soon as the County has collected enough money to design and construct them. The balance of the fees collected, which are not being used for debt service on the above-mentioned projects, will be allocated to Waste Management Capital Projects Fund for the purpose of completing the additional prioritized projects.

The Waste Management Committee reviewed the options in Attachment A. Fees have not been raised for the purpose of site maintenance, monitoring and improvements since 2005. There are approximately \$4,000,000 in capital improvements, which are mandated or have a high priority for completion at this time. The committee recognizes that residents of the county are going through difficult times for a number of reasons.

At the same time, the committee has a responsibility to give direction that will insure the County is maintaining best management practices for the oversight of its responsibilities.

The Committee recommends a 5% change in the gate rate which will increase the County Host Fee \$4.26 per trip. Additionally, a new usage fee of \$2.00 per trip for self-haul vehicles will be implemented as well. This will allow the County to pay the debt service on the projects over the next 30 years and begin the process of generating the funds necessary to complete the additional work as outlined.

Recommendation: Increase the Host Fee collected for the County by \$4.26 per trip and implement a \$2.00 fee per trip for self-haul vehicles at the Buena Vista Landfill site and the Pine Grove Transfer Station. .

### Dear SWA franchisees.

Please note that new facility fees at our North Area Recovery Station (NARS) and Kiefer Landfill (Kiefer) will take effect on November 1, 2020. Notably, the weighed load fees for normal refuse will be \$77.55 per ton at NARS and \$52.85 per ton at Kiefer. Additionally, weighed loads of green waste and wood waste will be charged \$99.75 per ton at both NARS and Kiefer. For the complete list of fees, please refer to the new NARS Fee Schedule and Kiefer Fee Schedule.

As you may know, fees for most of the material categories at both NARS and Kiefer have remained unchanged for more than 10 years. During this time, the County has endeavored to absorb rising costs and loss of revenues from the collapse of recycling markets without increasing fees. However, to continue providing services at standards that you have come to expect, it has become necessary to adjust our pricing.

The new fee schedules at Kiefer and NARS will help offset the impacts of inflation, recent increases in green waste and recycling processing costs, loss of revenue from declining materials prices, and additional compliance costs for new State mandates.

WHEREAS, the County of Amador owns the Buena Vista Landfill site; and

WHEREAS, the State of California (CalRecycle and the Regional Water Quality Control Board) oversees and regulates the maintenance and long term monitoring of the Buena Vista Landfill Site; and

WHEREAS, the County of Amador is responsible for maintaining the Buena Vista Landfill site; and

WHEREAS, the County of Amador is responsible for ongoing capital improvements required by the State, and for the safe and efficient operations of the facility; and

WHEREAS, the County operates its Waste Management operations like an Enterprise Fund and therefore strives for revenue neutrality; and

WHEREAS, the County has two projects required to be completed, by the State, in 2020-2021, and

WHEREAS, the County requires a revenue source to pay for the debt service on funding required for those projects, and

WHEREAS, the County wishes to designate revenue collected from these fees (Attachment A) annually into a debt service fund to pay the debt service (Attachment B) on the Phase One Waste Management Unit Final Cover Reconstruction, and the Class II Surface Impoundment Expansion and Liner Replacement projects, and

WHEREAS, the County requires a revenue source to pay for a number of additional capital improvements on the Buena Vista Landfill site, anticipated in the next ten years, and

WHEREAS, the County wishes to designate all the additional revenue collected from these fees annually into a Capital Projects Fund to pay for the Prioritized Buena Vista Landfill Capital Projects (Attachment C) as well as any other capital projects which may arise in the future, and

WHEREAS, the Board has previously adopted a contract with ACES Waste Services, Inc., which outlines these fees and requires them to be collected and remitted to the County, and

WHEREAS, the Board of Supervisors understands the safe and efficient operation of the Buena Vista Landfill Site is in the best interest of the residents of Amador County, and

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California, that the attached Capital Improvement fees schedule be adopted for users of the Pine Grove and Buena Vista Transfer Stations, effective September 22, 2020.
