A RESOLUTION OF THE CITY COUNCIL OF AMADOR CITY AUTHORIZING APPLICATION FOR, AND RECEIPT OF, LOCAL GOVERNMENT PLANNING SUPPORT GRANT PROGRAM FUNDS

WHEREAS, pursuant to Health and Safety Code 50515 et. Seq, the Department of Housing and Community Development (Department) is authorized to issue a Notice of Funding Availability (NOFA) as part of the Local Government Planning Support Grants Program (hereinafter referred to by the Department as the Local Early Action Planning Grants program or LEAP); and

WHEREAS, the City Council of Amador desires to submit a LEAP grant application package ("Application"), on the forms provided by the Department, for approval of grant funding for projects that assist in the preparation and adoption of planning documents and process improvements that accelerate housing production and facilitate compliance to implement the sixth cycle of the regional housing need assessment; and

WHEREAS, the Department has issued a NOFA and Application on January 27, 2020 in the amount of \$119,040,000 for assistance to all California Jurisdictions;

Now, therefore, the City Council of Amador City ("Applicant") resolves as follows:

SECTION 1. The Mayor is hereby authorized and directed to apply for and submit to the Department the Application package;

SECTION 2. In connection with the LEAP grant, if the Application is approved by the Department, the Mayor of the City of Amador City is authorized to submit the Application, enter into, execute, and deliver on behalf of the Applicant, a State of California Agreement (Standard Agreement) for the amount of \$65,000, and any and all other documents required or deemed necessary or appropriate to evidence and secure the LEAP grant, the Applicant's obligations related thereto, and all amendments thereto; and

SECTION 3. The Applicant shall be subject to the terms and conditions as specified in the NOFA, and the Standard Agreement provided by the Department after approval. The Application and any and all accompanying documents are incorporated in full as part of the Standard Agreement. Any and all activities funded, information provided, and timelines represented in the Application will be enforceable through the fully executed Standard Agreement. Pursuant to the NOFA and in conjunction with the terms of the Standard Agreement, the Applicant hereby agrees to use the funds for eligible uses and allowable expenditures in the manner presented and specifically identified in the approved Application.

While Amador City is the smallest city in California with an equally small budget, we still have to comply with all the necessary state regulations. The financial challenge to keeping compliant with current regulations is a constraint to housing and has the potential to become even more problematic. Staff has reviewed deficiencies in reporting and compliance and has identified three projects which would provide compliance with current regulations and/or reduce potential liabilities that could significantly impact the City s General Fund and thus ability to provide planning services for additional housing. The three projects are as follows:

- 1. Municipal Code Updates: The City is in the process of updating the Housing Element of the General Plan in compliance with the HCD s 6th Cycle. This update will mandate amendments to the Municipal Code to address current housing legislation and remove constraints to new housing development. The City will need to hire a planning consultant to perform the work.
- 2. Accessibility Compliance: Accessibility to city facilities can be a housing constraint to those with disabilities. Additionally, potential lawsuits resulting from lack of accessibility could have a "evastating impact on the City's General Fund which could result the inability to provide planning prvices. The first step in addressing accessibility issues is to review facilities and outline a compliance plan. The City is in receipt of a proposal to review and prepare a plan for the City to be in compliance with both California State disabled access standards and the Federal ADA Standards for Accessible Design.
- 3. Sewer System Master Plan (SSMP) Update: The State of California requires publicly owned sanitary sewer systems to develop and implement a Sewer System Management Plan (SSMP), including measures to control and mitigate sewer spills. Amador City is due for a comprehensive update in order to ensure compliance with state regulations. Non-compliance and insufficient maintenance of the City s sewer collection system could be a constraint to new housing development. The City Engineer has provided a proposal to update the City s SSMP as it has not undergone a comprehensive update since 2015.

Amador City is essentially staffed by consultants. For this reason, a small portion of the grant funds will be utilized to pay for administration of the grant.

Resolution of the City Council of Amador City
Regarding Passage of Measure K, a ballot measure that proposed a quarter
percent (1/4%) sales tax for the period of ten years for the sole purpose of
transportation improvements and qualified Amador City for eligibility for funding
from the California Transportation Commission's Local Partnership Program
for the same period of ten years.

Whereas, the one-quarter (1/4%) percent sales tax revenue passed by the City of Amador City voters in March 2024 is dedicated to transportation improvement. One hundred percent (100%) of the revenues generated by the new tax are allocated to transportation improvement and cannot be borrowed against or otherwise allocated to the General Fund.

Whereas, the one-quarter percent (1/4%) sales tax measure passed in March, 2024 by more than 2/3 of the registered voters in Amador City, qualified the City for eligibility for the California Transportation Commission's Local Partnership Program, from which the City can anticipate an allocation of \$200,000 per year for a period of ten years; and

Whereas, an independent auditor will complete a "Amador City Transactions and Use Tax Ordinance Report" annually to ensure that the one-quarter percent (1/4%) tax revenues are collected and managed properly and expended for the sole purpose of transportation improvements; and

Whereas, the City Council has established the "City of Amador City Transactions and Use Tax Oversight Committee", which will review the collection and expenditure of funds generated by the tax and will make recommendations to the City Council as appropriate; and

Whereas, the City spent \$8,552.85 in street funds for the fiscal year 2023-24, and has budgeted \$13,800 in street funds in the fiscal year 2024-25 for repair and maintenance. Current funding does not allow for any major street repair or reconstruction; and

Whereas, a preliminary report, prepared in February 2023 by the engineering firm Weber Ghio and Associates (WGA), indicates that Amador City has a total deferred road repair and maintenance need of approximately \$3.52 million for its eleven (11) streets; and

Whereas, the Office of Emergency Services (OES) for Amador County, in the event of wildfire or other natural disaster, has identified a single evacuation route or egress, Old Hwy 49/Main Street, for residents of Amador City and those living just outside the City limits, and

Whereas, in 2023, the preliminary engineering report prepared by WGA, estimated the total project cost to be approximately \$1,077,000.00; and

Therefore, be it further resolved that the City Council of Amador City identifies Main Street/Old Hwy 49 as a priority for transportation improvement; and

Therefore, be it further resolved that the City Council of Amador City shall continue to pursue eligibility for California Transportation Commission's Local Partnership Program and, once eligibility is established, nominate its priority project for funding.

The foregoing resolution was duly passed and adopted at a regular meeting of the City Council of Amador City, on the 17th day of October, 2024.
