# Regional Surface Transportation Program

The Regional Surface Transportation Program (RSTP) was established by California State Statute utilizing Surface Transportation Program Funds that are identified in Section 133 of Title 23 of the United States Code.

Projects eligible for funding from the RSTP include:

- ❖ Construction, reconstruction, rehabilitation, resurfacing, restoration, and operational improvements on
  1. Federal-aid highways (i.e., on any highways, including NHS and Interstate Highways that are not functionally classified as local or rural minor collectors).
  2. Bridges (including bridges on public roads of all functional classifications), including any such construction or reconstruction necessary to accommodate other transportation modes, and including the seismic retrofit and painting of and application of calcium magnesium acetate on bridges and approaches and other elevated structures.
- ❖ Mitigation of damage to wildlife, habitat, and ecosystems caused by a transportation project funded under RSTP.
- ❖ Capital costs for transit projects eligible for assistance under the Federal Transit Act and publicly owned intracity or intercity bus terminals and facilities.
- ❖ Carpool projects, fringe and corridor parking facilities and programs, and bicycle transportation and pedestrian walkways on any public roads in accordance with Section 217 of Title 23, U.S.C.
- ❖ Highway and transit safety improvements and programs, hazard elimination, projects to mitigate hazards caused by wildlife, and railway-highway grade crossings. Safety improvements are eligible on public roads of all functional classifications
- ❖ Highway and transit research and development and technology transfer programs.
- ❖ Capital and operating costs for traffic monitoring, management and control facilities and programs.
- ❖ Surface transportation planning programs
- ❖ Transportation enhancement activities.
- ❖ Transportation control measures listed in Section 108 (f)(1)(A) (other than clauses xii & xvi) of the Clean Air Act.
- ❖ Development and establishment of management systems under Section 303 of Title 23, U.S.C.
- ❖ Wetlands mitigation efforts related to RSTP projects.

In accordance with Section 133 (b) of Title 23 of the United States Code, approximately 70% (\$225 million dollars per year) of the state's RSTP funds must be obligated on projects which are located within the 11 urbanized areas of California with populations greater than 200,000 people. (See attached map for UZAs greater than 200,000 population). The apportionment and distribution for such obligation is calculated based on relative population.

### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AMADOR CITY VACATING A PORTION OF MAIN STREET AS OUTLINED IN EXHIBIT A

WHEREAS, the City of Amador City received a request from Aaron Brusatori, owner of a portion of Lot 23, Block 1, Amador City Townsite, to vacate a portion of Main Street (Old State Route 49) in the city limits; and

WHEREAS, this street vacation request is for approximately 5,030 SF of Main Street, originally part of said Lot 23, in the City of Amador City; and

WHEREAS, a public hearing is required to hear testimony regarding the vacation of city owned street rights of way pursuant to Streets and Highways Code Section 8320; and

WHEREAS, Exhibit A depicts the Notice that was published and posted pursuant to Section 8322 and 8323 of said code; and

WHEREAS, the City Council held said public hearing and heard public testimony and finds the said 5,030 SF of Main Street is unnecessary for present or future public use.

NOW THEREFORE BE IT RESOLVED the City Council of the City of Amador City hereby authorizes the City Engineer to proceed with preparation of a deed and legal description to complete the vacation as outlined in Exhibit A transferring said street vacation limits to Aaron Brusatori, owner of the remaining portions of said Lot 23; and

BE IT FURTHER RESOLVED the Mayor is hereby authorized to execute said deed on behalf of the City after all costs to City have been reimbursed.

BE IT FURTHER RESOLVED all city staff costs associated with said vacation shall be reimbursed prior to deed recording.

**Incident Period**

Eligibility of Public Assistance costs, as a result of the January 2017 Storms, will be based on events that occurred within the incident period of January 3, 2017, through January 12, 2017. Pursuant to Title 44 of the Code of Federal Regulations (44 CFR) section 206.202, any known damage that occurred within the incident period must have been reported to Cal OES within 60 days of the Recovery Scoping Meeting, formerly known as the Kickoff Meeting, to be eligible for federal assistance.

**Deadline to Identify Projects**

Project Worksheets (PW) are the reimbursement vehicles used to fund disaster projects. PWs are used to document the location, damage description and dimensions, scope of work, and cost estimate for each project. The PW is the basis for funding and all cost estimates and damages must be identified within 60 days following the Recovery Scoping Meeting for each of those projects identified on the Subrecipient's List of Projects. Damages and costs must be estimated when final supporting documents are not yet available. City of Amador City is strongly encouraged to submit PW information as soon as possible to expedite the assistance and funding process.
